SIA Website Analytics Tracking

- How do we compile all the data from the SIA website throughout the years?
 - o Would need to be accompanied by messaging
 - Highlight return users
 - "This # of users have found the resource hub to be an important tool, etc."
 - Find ways to try and raise the number of returning users
 - o Keep in mind What story are we telling?
 - Have a space for users to leave comments on the website so we can learn who is using the site
 - Pop up prompt in the corner
 - 'are you a community member?' / 'do you want to sign up for our newsletter?'
 - Advertise the website to the community
 - Simplify the website analytics into percentages

Tracking SI Alliance Impact

- Early Learn Environment Data Tracking Suggestions
 - IEP data (3y/o up)
 - DEFINE WHAT THE GOALS ARE
 - Supporting educators; ADVOCATING FOR FAMILIES
 - Figure out the overall goal and collect and use the relevant data to support that overall goal
 - Challenging behaviors vs learning disabilities



- Implicit biases
- Data would be useful on a case-by-case basis difficult to use it on a grander scale
- Work with a sample group through UNECE (Not sure on the possibilities)
 - Cognitive Development lab @ CSI
- Why are ELLs counted with IEPs dissect the implicit bias within the comparison
 - Are we looking to increase or decrease the amount of IEPs
 - o Children should be getting the support they need
- o PD Data
 - Focusing on mandatory trainings
- o Enrollment Data
 - Goal: increase enrollment
 - Resource hub: reach out to the schools that are listed keep the # of available seats updated
 - Do outreach to schools
- ELE Feedback Data Tracking Suggestions
 - Parental (family) interest in short workshops / series
 - Are parents interested in engaging in school activities?
 - Are parents available to attend school activities / workshops (timeframes)?
 - O What programs / workshops are parents interested in?
 - Has the KT initiative helped keep families more involved over the school vear?
 - Pick one or two data points and events to focus on to avoid being overwhelmed
 - Bring to Advisory Board for further discussion
 - Work with SI Mental Health data on children receiving therapy vs children with an IEP

New Data Review

- Child Readiness Indicator Data
 - Early Childhood Professional Development



- # of in person trainings vs virtual trainings
 - 2021 high jump in online trainings
 - o Has maintained high numbers since
 - In person trainings have risen since drop in 2021
- Small # attended ONLY in person trainings in 2023 (43)
 - Much higher # attended only virtual trainings (226)
 - Highest # are those who did not attend ANY trainings in 2023
- Source of data is from the Aspire Registry all trainings are listed as MANDATORY
 - Issue with data not all trainings are registered with Aspire
 - Educators can be taking classes / trainings through other providers
- Noticed a lack of participation in trainings around dealing with / supporting children with challenging behaviors
 - Recent addition to the list of mandatory meetings
